WAIVER & RELEASE FORM

Students may suffer injuries possibly minor, serious or catastrophic in nature. Dance and other physical activities can be dangerous and can lead to injury or death.

Parents should make their children aware of the possibility of injury and encourage their children to follow all of the safety rules and the coaches' and staff member's instructions.

Desiree's Dance Studio, LLC its coaches and other staff members, will not accept responsibility for injuries sustained by any student during the course of dance and other physical activities, or in the course of any exhibition, or clinic in which he/she may participate, or while traveling to or from the event.
